DISCOUNTS AND ADJUSTED GROSS INCOME LEVELS ARE SUBJECT TO CHANGE WITH CHANGES IN THE POVERTY INCOME GUIDELINES, FEDERAL TAX LAWS AND AT THE DISCRETION OF THE MIDDLESEX HOSPITAL.
